STATUTES RELATING TO CENTRE FOR AMBEDIAR'S STUDIES, RESEARCH & EXTENSION-2004 IN THE UNIVERSITY OF MYSORE

1. Preamble and Justification:

Dr. B.R.Ambedkar was a man of versatile genius, economist, jurist, constitutionalist, social reformist, a political thinker, a champion of the downtrodden and above all a great humanist. His relentless struggle has not only awakened British administration but also opened the eyes of the caste Hindus regarding the unjust social, religious and political practices of the country. His erudition and learning reflected in his speeches and writings have served as a beacon light for rational approach towards the existing social and religious problems. Thus Ambedkar's thoughts have assumed more relevance in the globalised society today. With a view to inculcate his ideals and thoughts among youth and others, to undertake research and extension activities for disseminating the basic tenets and values propounded by Ambedkar to evolve an egalitarian society, the establishment of a Centre for Ambedkar Studies, Research and Extension in the University of Mysore was felt necessary, as it is one of the oldest Universities in the country and the same has been established in the year 2000. Further, the Platinum Jubilee Chair for Dr.B.R.Ambedkar Studies established in the year 1994 (which was supposed to be rotated among various departments as per the Statute framed for the purpose under Section 35(n) of the Karnataka State Universities Act 1976) is proposed to be attached with this Centre.

Hence, the following Statutes have been framed.

2. Short Title:

These Statutes shall be called "CENTRE FOR DR. B.R.AMBEDKAR STUDIES, RESEARCH AND EXTENSION STATUTES-2004" framed under Section 40(1)(f)(h) and (i) read with Section 29(2)(1), 34(6),(7)(8) and 33(1)(2) of the Karnataka State Universities Act – 2000.

3. Commencement:

These Statues shall come into force from the date they are assented to by His Excellency the Chancellor.

The Centre for Dr. B.R.Ambedkar Studies, Research and Extension shall be one of the Teaching and Research Department of the University of Mysore and shall offer courses in Ambedkar Studies. The Centre shall conduct teaching and research programme leading to Certificiate, P.G.Diploma, M.A., M.Phil, and Ph.D, degrees and organize extension programmes on Ambedkar's philosophy and related areas.

5. Objectives:

- 5.1 To study Ambedkar's thoughts and philosophy and their relevance to the contemporary society:
- 5.2 To study the impact of ideologies of Ambedkar-such as Liberalism, Democracy, Socialism and Marxism in reconstruction of Indian Society,
- 5.3 To study the impact of various socio-political ideologies on Ambedkar's thinking;
- 5.4 To study Ambedkar's constitutional and legal thoughts and their relevance in the contemporary society;
- 5.5 To study contemporary versions of religion with special reference to Buddhism as perceived by Ambedkar;
- 5.6 To compare and contrast Ambedkar's philosophy with Buddha, Basaveshwara, Jyothiba Phule, Karl Marx, Gandhi, Lohia and other social thinkers;
- 5.7 To study Ambedkar's perception of socio-economic change,
- 5.8 To offer courses at different levels to teach Ambedkar's ideology and philosophy to the youth in particular and others in general;
- 5.9 To undertake research, publishing, training and extension activities on and about Ambedkar and his philosophy and related areas.

6. Departmental Council:

As provided under Section 34(6) of the Karnataka State Universities Act 2000, the Centre shall have the Departmental Council consisting of the members as prescribed

7. Board of Studies:

As prescribed in Section 33 (1) & (2) of the KSU Act, 2000 there shall be a Board of Studies in Ambedkar Studies and shall carry on its functions as per the Statutes of the University in this regard.

8. Teaching and other Staff:

The Centre shall have the following staff:

NOTE

- a) <u>Director:</u> The Centre shall have a Director appointed by the Syndicate and shall be in-charge of the administration of the Centre as per the provisions under Section 34(7) and 34(8) of the KSU Act 2000.
- b) Reader: The post of the Reader in the Department of Studies in Ancient History & Archeology has already been identified and re-deployed by the University Syndicate and appointment has already been made under backlog category.
- c) <u>Lecturers</u>: One post has been identified and re-deployed from CISL by the University Syndicate and appointment has already been made under backlog category. One more post shall be identified and re-deployed by the University Syndicate.
- d) All the remaining Non-teaching and Ministerial Posts mentioned at 8.4 to 8.8 shall be filled-up on re-deployment basis.

9. Dr. AMBEDKAR CHAIR:

- (i) The Platinum Jubilee Chair for Dr.B.R.Ambedkar Studies already established during the year 1994 vide Notification No.DV7/558/92-93 dated 07-10-1994 shall be attached to this Centre.
- (ii) Location: "Dr.B.R.Ambedkar Chair" shall be located in the 'Centre for Ambedkar Studies, Research and Extension', Manasagangotri, Mysore.

(iii) Objectives of the said Chair:

- a) To study the possibilities of the establishment of Casteless Society in India.
- b) To study the Indian Constitution and its impact on the present judgments of the Courts, Politicians and poor people.

- c) To study the welfare schemes of the State Government/Central Government and their achievements.
- d) To study the Reservation Policy of the Government for SC/ST's
- e) Publication of literature on Dr.B.R.Ambedkar, arranging seminars, workshops, conferences etc.,
- (iv) There shall be a Visiting Professor selected from amongst Professors, retired Judges, eminent Lawyers and noted Social Workers who have worked for the up-liftment of the Weaker Sections of the Society.
- (v) Such selection shall be made by the Syndicate and appointed on invitation basis for a period of not less than Six months and not exceeding One year.
- (vi) A Visiting Professor so appointed shall be eligible for an honorarium of Rs.8,000/per month and free accommodation in the University Guest House,
 Manasagangotri, Mysore. In the case of in-service Professor, his total emoluments
 will be protected. The Visiting Professor shall be entitled to receive T.A. and D.A
 as per University rules, while reporting for duty and while relieving from duty. All
 such expenses shall be met out of the interest accrued from the corpus fund
 already earmarked to the Chair.
- (vii) The Visiting Professor shall deliver atleast four lecutrues in a month during his tenure and work towards realization of the objectives stated under section 9(3) of the statutes. Further he/she shall submit a brief report of the achievements of the Chair during the tenure of his appointment.
- (Viii) The Director of the Centre shall extend co-operation to the Visiting Professor in conducting Seminars, Workshops, Study Circles etc.,

REPEAL: In view of the inclusion of the "Dr.B.R.Ambedkar Chair" as part of the Centre, the Statutes relating to "Platinum Jubilee Chair" for Dr.B.R.Ambedkar Studies Statute-1994 notified vide Notification No.DV7/558/92-93 dated 07-10-1994 shall stand repealed.
