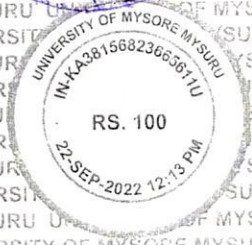

### About University of Mysore

The University of Mysore is one of the famous, prestigious and very few oldest universities in India. The University was founded as a result of the efforts made by the benevolent and visionary Maharaja of erstwhile Princely State of Mysore His Highness 'Rajarshi' Shri Nalvadi Krishnaraja Wadiyar -IV (1884-1940) and the then Diwan Sir. M. Vishvesvaraya (1860-1962). Prior to that, all the institutions of Higher Education and Colleges within the Mysore State was under the administration of Madras Presidency and were functioning under Madras University.

Mysore University is the first University in Karnataka State to be accredited by NAAC and has undergone NAAC Accreditation Thrice – First in 2000 with 'Five Star' Status, second time in 2006 with a 'A+' Level and for the Third time in 2012 with a CGPA score of 3.47 on a 4 point scale. NAAC has designated Mysore University as a 'High performing Institution;'. The University Grants Commission has placed Mysore University Under Tier -II Category of Graded Autonomy. Govt. of India has recognized Mysore University as "Institution of Excellence (IOE)" in 2008 while the UGC has recognized Mysore University as a University with Potential for Excellence (UPE) in 2009. On the other hand Mysore University is also recognized as a centre with potential for Excellence in a Particular Area (CPEPA). On the recommendations of Karnataka Knowledge commission, the Karnataka government has considered Mysore University as an "Innovative University". Current Science has ranked Mysore University as one of the top 20 Universities Scientific and Research endeavors.

From the four PG Campuses namely Mysore (Manasagangothri), Mandya (Thubinakere), Hassan (Hemagangothri) and Chamarajanagar (Suvarnagangothri) there are 63 PG Departments offering 76 Postgraduate, M.Phil and Ph.D. Programmes. There are 219 affiliated colleges.

- V. The University of Mysore shall extend all Intellectual Support as Knowledge Partner to Organise the Seminars, Programs, Conferences and International Conferences in Karnataka State as well as in all over India.

##### 2. Objectives of MOU

- b) To make the Rural Women of Scheduled Castes and Scheduled Tribes community self-reliant by organizing their Self-Help Groups (SHGs) and to train and promote them
- c) To implement various integrity based programmes to develop the leadership capacity and inculcating the sense of belongings amongst people of Scheduled Castes and Scheduled Tribes community.

### 3. Scope of MoU

- a. MoU with University of Mysore and research/education mutually work and assist (Whenever & Wherever required) on planning, research to motivate, to encourage, farmers, students, youth & aspiring entrepreneurs to start working for all Sectors of Industries by Innovative ideas, clusters, co-operative sectors.
- b. To assist in establishing new and innovative businesses
- c. Information on research / education resources
- d. Delivering specific solution in terms of R&D, Product development etc.
- e. To Organize Awareness/Training/Seminars and Workshops
- f. University of Mysore will appoint One NODAL OFFICER to Coordinate with FSCSTLP-DACC and Vice versa.
- g. University of Mysore will provide all Technical/IT and Official Administrative Support to FSCSTLP-DACC While presentations/Meetings/Conferences/Seminars at STATES LEVEL/NATIONAL LEVEL.
- h. University of Mysore along with FSCSTLP-DACC will explore the Possibilities to Establish One Centre in Main Campus on the name of BHARAT RATNA DR. B. R. AMBEDKAR CENTRE FOR ENREPRENURESHIP and also try to establish at other States of India.
- i. University of Mysore will provide Infrastructural and other required Support by setting up of office for the FSCSTLP & DACC in the Campus of UOM along with dedicated Clerical Staff/ Research Scholars/ Senior Students/ Volunteers and required facilities.

### 4. Terms and conditions

There is no financial commitment on the part of University of Mysore or FSCSTLP-DACC. Both the Institutes agree to help identify and invite faculty members and researchers from other institutes to participate in conferences, workshops and short-term courses / training.

### 5. Coordinators

Both FSCSTLP-DACC and University of Mysore, will designate persons who will have responsibility for coordination and implementations of this MoU.

## 6. Indemnity

## 7. Intellectual Property Rights

The Intellectual Property Rights (IPR) that arises as a result of join research and collaborative activity under the agreement will be worked out on a case basis and will be consistent with officially laid down IPR policies of the two institutes

## 8. Jurisdiction

Any disputes arising out of this MoU shall be subjected to the Jurisdiction of Mysore. The Law courts / District courts at Mysore shall have exclusive Jurisdiction over the dispute.

## 9. Confidentiality Clause

The parties may disclose certain confidential information to the other in relation to any future proposals made under this MoU. Each party therefore agrees that contents of this MoU and the negotiations in relations to any future proposal remain strictly confidential and each party hereby undertakes not to disclose the same to third party without the prior written consent of the other party except where such disclosure is required by law.

## 10. Signed in Duplicate

This MoU executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the institute, acting by their duty authorised officers has caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.

## 11. Terms of MoU

The MoU shall remain valid for a period for five (5) years from the date of signing of the MoU by both the parties, renewable further if mutually agreed. Either party may terminate the MoU by written notification signed by the appropriate official of the institution initiating the notice. Such notice must be received by the other party six months prior to the effective termination
