- 2) These promotions are subject to the Audit objections and directions/clarifications of the University Grants Commission regarding the extension of the promotion under UGC-CAS vide at reference (5) to a teacher who has completed Refresher Course/Orientation Program after the eligibility date of promotion. If the directions/clarifications comes against the teacher, the amount paid is liable to be recovered.
- 3) These promotions are subject to any modifications issued subsequently from the concerned authorities. The concerned teacher should abide such modifications.

Further, the teacher must give an undertaking in writing regarding that the above terms and conditions that he shall abide to the same.
